2.0 TERMS:

- 2.2 Both departments will organize jointly student's seminar, induction programme, community development programmes etc. time-to-time and the expenses of such programmes will be shared by the both institutions.

3. VALIDITY:

- 3.1 The agreement will be valid until it is expressly terminated by either party on mutually agreed terms.
- 3.2 Both parties may terminate this MoU upon 30 calendar days' notice in writing.
- 3.2 This MoU will be renewed after five years upon the consent in writing of both departments.
- 3.3 Details of the implementation of any particular exchange resulting from this MoU shall be negotiated between the two departments.
